



THE WEDDING EXPO

1. This competition runs from 09h00 on Saturday 8 June until 14h00 on Sunday 9 June 2019

3. 10 finalists will be drawn. The finalists will then need to be present at 15h00 on Sunday 9 June at The Wedding Expo to be entered into a draw to pick the winner.
